



**ADDENDUM NO. 1**

**YELM HIGHWAY COMMUNITY PARK MASTER PLAN**

This addendum takes precedence in resolving inconsistencies in any parts of the contract documents. This addendum consists of **Two (2) pages**. Bidders are hereby notified that the bidding documents have been amended as follows:

**QUESTIONS AND ANSWERS**

**Q.** Is the date for completion correctly listed as 2020? That seems like more than enough time to complete the master plan?

**A.** December 2020 is the absolute deadline, however we anticipate and encourage it to be completed sooner.

**Q.** It is clear that the resume pages are not counted in the 12 page maximum for the submittal text. Is there a limit on the number of pages for resumes?

**A.** No, there is not an overall page limit for resumes, but please keep each individual resume to a 1 page limit.

**Q.** Regarding “integrating urban design principles and artistic elements into plans and municipal projects” is it the intent that the design team will be developing the art or that the design team is to work with an artist selected by the city, or that there is existing art piece or pieces to be integrated in the design? If an artist is to be selected, will the design team participate in selecting the artist?

**A.** It is intended that the design team include at least one professional specializing in public art. The artist should be involved throughout the design process to weave artistic elements throughout the project site. Your statement of qualifications should describe your approach to integrating art into the master plan and identify the professional(s) specializing in public art on your design team.
