I am sorry that I missed your call today. In essence, my question is this:

Steve Thompson reviewed Tom Skilling's report that identified four areas of concern: the north-south ditch; the east-west ditch; the lack of a downstream analysis; and the mounding analysis. Mr. Thompson said the City agreed with two of Skilling's concerns: the north-south ditch and the east-west ditch. Your Staff Report Addendum, however, concludes that no changes to the MDNS conditions are required, even though Mr. Thompson agreed with two of Skilling's concerns. Is that because you believe the existing conditions in the MDNS already address Skilling's concerns regarding the north-south and east-west ditches?
