The West Olympia Access Study is a partnership effort between the City of Olympia and the Washington State Department of Transportation to better understand current and future mobility issues on the west side of Olympia. The goal is to identify a package of measures for improving access and circulation for all travelers.

Come to one of the two open houses to learn about recent activities and next steps:

- Scenarios look at alternate ways of improving access and circulation on Olympia’s west side
- Traffic analysis models simulate US 101 interchange conditions today and in the future
- Local projects improve safety and mobility for cyclists, walkers and drivers
- Transit opportunities and challenges are considered
- Modifications of the US 101/Black Lake Boulevard and the US 101/Evergreen Parkway interchanges are evaluated
- Neighborhood connectivity issues are presented
- Study resources and documents are available

This is an opportunity to find out what changes to the transportation system engineers and planners are considering and how they are evaluating choices for improving west side mobility. These open houses are designed to let you focus on your particular areas of interest and to get your specific questions answered. Stay for 30 minutes or stay three hours – the choice is yours.
